I further assume all risks which may be involved in my participation, particularly hazards due to the conditions of the Mexican boats chartered by the Tournament for the purpose and weather conditions, and I fully understand that at any time during the Tournament I may elect not to participate when I think boat or weather conditions are too hazardous for my safety, to the same extent that I would do if I were chartering the boat for my own personal use.

Tournament Entry Priority: First priority is to all 2023 Eastcape Anglers; Second priority is to all TAA Lifetime members; Last priority is the order of receipt of applications.

Changes: If you plan to arrive early or stay late please make your own arrangements with Van Wormer Resorts 877-777-8862 or www.vanwormerresorts.com. June is normally the busiest time for the hotel, so please plan accordingly..

Format: 30lb test monofilament line. Anglers supply their own line and at least two rods and reels. We fish two anglers per boat and use lures, and live or dead bait. **Non-offset circle hooks** must be used with bait. All bait is included in the costs. The Tournament will determine the amount of bait for each boat based on availability at the time. Except where otherwise noted, IGFA Rules apply.

NOTE: Spinning gear may be used at the angler's discretion.

Scoring:

300 points plus bonuses for Blue or Black Marlin and Broadbill swordfish

200 points plus bonuses for Striped Marlin

100 points plus bonuses for Sailfish

10 points for yellowfin tuna, dorado, and wahoo. Daily boat limit 6 for each species
